

Chulalongkorn University Announcement Regarding applications for students in the Bachelor of Science in Applied Chemistry (International Program), Faculty of Science for the 2025 academic year (International Admission)

Chulalongkorn University is now accepting Applications for Students in the Bachelor of Science in Applied Chemistry (International Program), Faculty of Science for the 2025 academic year (International Admission). Application process is as follows.

1. Application Requirements

Applicants do not hold Thai citizenship and have completed high school or passed an equivalent high school standard test or be currently in their final year of high school (Grade 12 in the US system or Year 13 in the British system).

- 1.1 Applicants must submit all of the following three documents in which at least 2 out of 3 score results must meet the requirements.
 - 1.1.1 Applicants must achieve the prescribed minimum score in any one of the following English Proficiency tests:

The official score reports of the tests in 1.1.1, 1.1.2 and 1.1.3 or 1.2.1), 1.2.2) and 1.2.3) are valid only if the tests were taken no more than two years prior to the application deadline.

1.3 All applicants must have a history of good behaviour and agree to abide strictly by existing and any future University regulations, codes and policies.

2. Number of Available Places

The Bachelor of Science in Applied Chemistry (International Program), Faculty of Science, is authorized to admit up to 10 (Ten) qualified applicants.

3. Application Schedule and Application Fee

- 3.1 Application Schedule
 - Apply via email: The applicant must submit their electronic copy of application form and all required documents as stated in item 4 (either in PDF or graphic file format) to learnbsac@gmail.com. There are two rounds of application as follows; 25th December 2024 – 5th February 2025 First round application: Second round application: 20th March – 2nd May 2025 (The second round of application will take place on the condition that the announced number is not met in the first round.)
 - 3.1.2 Application Fee Payment

For the first round application, please pay the fee between 25th December 2024 - 5th February 2025.

For the second round application (if any), please pay the fee between 20th March – 2nd May 2025.

The applicants may pay the 1,000 Baht application fee through SCB Bank, account name: FACULTY OF SCIENCE CHULALONGKORN UNIVERSITY COMP CODE 0426 (SAPHA KACHAT THAI BRANCH). The applicants may download the application fee form at http://bsac.chemcu.org.

3.2 Application Fees

The application fee is 1,000 Thai Baht (transaction fees and surcharges not industrial)

4. Application Package

Applicants must complete the application form in full and ensure that all information given is true and correct. All application forms must be accompanied by the following:

- Photograph
- Academic transcript (s)
- Copies of exam results as specified in item 1
- A copy of the applicant's passport
- A letter of recommendation
- A proof of application fee payment

5. Application Process Details

- 5.1 First Round Application
 - 5.1.1 Announcing Applicants Qualified for Interview
 The Faculty of Science will announce applicants qualified for interview on 11th February
 2025 on the website (http://bsac.chemcu.org)
 - 5.1.2 Interview (Online)

 Applicants qualified for an interview will be examined online between 14th 20th

 February 2025. If an applicant does not report for interview, that applicant will be disqualified.
 - 5.1.3 Announcement of Applicants who Have Passed the Interview

 The Faculty of Science will announce applicants who have passed the interview as well as details on how to confirm acceptance of offer of place on 26th February 2025 on the BSAC website (http://bsac.chemcu.org).
 - 5.1.4 Accepting Offer of Place and Paying the Admission Confirmation Fee Applicants who have passed the interview must report to accept offer of place and make the admission confirmation fee payment between 28th February 6th March 2025. If an applicant fails to do so by the appointed time, they will be assumed to have rejected the offer of place.
 - 5.1.5 Announcement of Additional Qualified Applicants (If Any)

 The Faculty of Science will announce additional applicants who have passed the interview on the BSAC website (http://bsac.chemcu.org). Additional applicants who have passed the interview must report to accept offer of place and pay the admission confirmation fee between 7th 11th March 2025. If an applicant fails to do so by the appointed time, they will be assumed to have rejected the offer of place.

5.1.6 Announcement of Applicants who have Confirmed Acceptance of Offer of Place and Paid for the Admission Confirmation Fee

The Faculty of Science will announce applicants who have confirmed acceptance of offer of place and paid for the admission confirmation fee by email between 28th February– 13th March 2025.

Successful applicants who have confirmed acceptance of offer of place and paid for the admission confirmation fee will not be eligible for the second-round application. The BSAC program reserves the right not to refund the application fee to applicants.

5.2 Second Round Application (If Any)

The second round of application will take place on the condition that the announced number is not met in the first round.

- 5.2.1 Announcing Applicants Qualified for Interview

 The Faculty of Science will announce applicants qualified for interview on 8th May 2025 on the website (http://bsac.chemcu.org).
- 5.2.2 Interview (Online)

 Applicants qualified for an interview will be examined online between 13th 16th May 2025. If an applicant does not report for interview, that applicant will be disqualified.
- 5.2.3 Announcement of Applicants who Have Passed the Interview

 The Faculty of Science will announce applicants who have passed the interview as well as details on how to confirm acceptance of offer of place on 21st May 2025 on the BSAC website (http://bsac.chemcu.org).
- 5.2.4 Accepting Offer of Place and Paying the Admission Confirmation Fee Applicants who have passed the interview must report to accept offer of place and make the admission confirmation fee payment between 23rd 28th May 2025. If an applicant fails to do so by the appointed time, they will be assumed to have rejected the offer of place.
- 5.2.5 Announcement of additional qualified applicants (if any)

 The Faculty of Science will announce additional applicants who have passed the interview on the BSAC website (http://bsac.chemcu.org). Additional applicants who have passed the interview must report to accept offer of place and pay the admission confirmation fee between 29th May 2nd June 2025. If an applicant fails to do so by the appointed time, they will be assumed to have rejected the offer of place.
- 5.2.6 Announcement of Applicants who have Confirmed Acceptance of Offer of Place and Paid for the Admission Confirmation Fee

The Faculty of Science will announce applicants who have confirmed accept offer of place and paid for the admission confirmation fee by email between - 4th June 2025. 6. Announcement of Applicants with the Right to Study (from the first and second round applications)

Chulalongkorn University will announce applicants with the right to study the Bachelor of Science in Applied Chemistry (International Program) for the 2025 academic year (international round) on 12th June 2025 at BSAC website (http://bsac.chemcu.org).

7. Conditions of Study

- 7.1 An individual must have completed Mattayom 6 or equivalent to be qualified to register as a student of Chulalongkorn University. Should it emerge that applicants with right to study have found to have provided false information in the application or false evidence in support of the application, their right to study will be rescinded. The BSAC program reserves the right not to refund the application fee and the admission confirmation fee to applicants.
- 7.2 Individuals who have completed their education at an international school or a foreign school that was not certified by the Ministry of Education must have their qualification certified by the Council of University Presidents of Thailand as being equal to a qualification according to the Ministry of Education's Basic Education Core Curriculum.
- 7.3 Should it emerge that applicants with right to study have found to have provided false information in the application or false evidence in support of the application, their right to study will be rescinded. The applicant may also face criminal charges.

8. University Tuition Fees and Extra Surcharges

University tuition fees and surcharges will be charged according to announcements by Chulalongkorn University.
