Admission to the Bachelor of Science in Applied Chemistry (International Program), Faculty of Science for the Academic Year 2026 (International Admission)

Chulalongkorn University hereby announces the acceptance of applications for admission to the Bachelor of Science in Applied Chemistry (International Program), Faculty of Science, for the academic year 2026 (International Admission). Details of the application process are as follows.

1. Application Requirements

Applicants must not hold Thai citizenship and have completed high school education or its equivalent, or be currently in their final year of high school (Grade 12 in the U.S. system or Year 13 in the British system).

- 1.1 Applicants must submit three types of score reports as follows, of which at least two must meet the requirements.
 - 1.1.1 Applicants must achieve the prescribed minimum score in any one of the following English Proficiency Tests:

All test scores are valid for two years from the test date to the application deadline.

1.3 All applicants must possess good moral character and agree to abide strictly by existing and any future University regulations, codes and policies.

2. Number of Available Places

The Bachelor of Science in Applied Chemistry (International Program), Faculty of Science, is authorized to admit up to 10 (Ten) qualified applicants.

3. Application Schedule and Application Fee

- 3.1 Application Schedule
 - 3.1.1 Apply online at the Sci Online Inter Admission website (http://intl-admission.sc.chula.ac.th). There are two rounds of application as follows:

First round application: 22nd December 2025 – 6th February 2026

Second round application: 20th March – 1st May 2026 (The second round application will take place on the condition that the announced number,

met in the first round.)

3.1.2 Application Fee Payment

For the first round application, please pay the fee between 22^{nd} December 2025 – 6^{th} February 2026.

For the second round application (if any), please pay the fee between 20^{th} March – 1^{st} May 2026.

The applicants may pay the 1,000 Baht application fee through SCB Bank, account name: FACULTY OF SCIENCE CHULALONGKORN UNIVERSITY COMP CODE 0426 (SAPHA KACHAT THAI BRANCH). The applicants may download the application fee form at http://intl-admission.sc.chula.ac.th.

3.2 Application Fees

The application fee is 1,000 Thai Baht (transaction fees and surcharges not included).

4. Application Package

Applicants must complete the online application form and ensure that all information given is true and correct. The online application form must be accompanied by the following:

- Recent photograph
- Academic transcript(s)
- Required test results as specified in item 1
- Copy of the applicant's passport
- Proof of payment of the application fee

5. Application Process Details

5.1 First Round Application

5.1.1 Announcing Applicants Qualified for Interview

The Faculty of Science will announce applicants qualified for interview on 11th February 2026 on the Sci Online Inter Admission website (http://intl-admission.sc.chula.ac.th)

5.1.2 Interview (Online)

Applicants qualified for an interview will be examined online between $16^{th} - 20^{th}$ February 2026. If an applicant does not report for interview, that applicant will be disqualified.

5.1.3 Announcement of Applicants who Have Passed the Interview of The Faculty of Science will announce applicants who have passed the Interview as well as details on how to confirm acceptance of offer of place on 24 February 2026 on the Sci Online Inter Admission website

5.1.4 Accepting Offer of Place and Paying the Admission Confirmation Fee

Applicants who have passed the interview must report to accept offer of place and make the admission confirmation fee payment between 26th February – 3rd March 2026. If an applicant fails to do so by the appointed time, they will be assumed to have rejected the offer of place.

5.1.5 Announcement of Additional Qualified Applicants (If Any)

The Faculty of Science will announce additional applicants who have passed the interview on the Sci Online Inter Admission website. Additional applicants who have passed the interview must report to accept offer of place and pay the admission confirmation fee between 4^{th} – 9^{th} March 2026. If an applicant fails to do so by the appointed time, they will be assumed to have rejected the offer of place.

5.1.6 Announcement of Applicants who have Confirmed Acceptance of Offer of Place and Paid for the Admission Confirmation Fee

The Faculty of Science will announce applicants who have confirmed acceptance of offer of place and paid for the admission confirmation fee by email between 27th February – 10th March 2026.

Successful applicants who have confirmed acceptance of offer of place and paid for the admission confirmation fee will not be eligible for the second-round application. The BSAC program reserves the right not to refund the application fee to applicants.

5.2 Second Round Application (If Any)

The second round of application will take place on the condition that the announced number is not met in the first round.

5.2.1 Announcing Applicants Qualified for Interview

The Faculty of Science will announce applicants qualified for interview on **7th May 2026** on the Sci Online Inter Admission website (http://intl-admission.sc.chula.ac.th)

5.2.2 Interview (Online)

Applicants qualified for an interview will be examined online between 12th – 15th May 2026. If an applicant does not report for interview, that applicant will be disqualified.

5.2.3 Announcement of Applicants who Have Passed the Interview

The Faculty of Science will announce applicants who have passed the interval well as details on how to confirm acceptance of offer of place on 19th on the Sci Online Inter Admission website.

5.2.4 Accepting Offer of Place and Paying the Admission Confirmation Fee

Applicants who have passed the interview must report to accept offer of place and make the admission confirmation fee payment between 21st – 26th May 2026. If an applicant fails to do so by the appointed time, they will be assumed to have rejected the offer of place.

5.2.5 Announcement of additional qualified applicants (if any)

The Faculty of Science will announce additional applicants who have passed the interview on the Sci Online Inter Admission website. Additional applicants who have passed the interview must report to accept offer of place and pay the admission confirmation fee between 27th May – 1st June 2026. If an applicant fails to do so by the appointed time, they will be assumed to have rejected the offer of place.

5.2.6 Announcement of Applicants who have Confirmed Acceptance of Offer of Place and Paid for the Admission Confirmation Fee

The Faculty of Science will announce applicants who have confirmed acceptance of offer of place and paid for the admission confirmation fee by email between 22^{nd} May -2^{nd} June 2026.

6. Announcement of Applicants with the Right to Study (from the first and second round applications)

Chulalongkorn University will announce applicants with the right to study the Bachelor of Science in Applied Chemistry (International Program) for the academic year 2026 (international round) on 10th June 2026 at the Sci Online Inter Admission website (http://intl-admission.sc.chula.ac.th).

7. Conditions of Study

7.1 Applicants must have completed Matthayom 6 or its equivalent to be eligible for registration as a student of Chulalongkorn University. Should it emerge that applicants with right to study have found to have provided false information in the application or false evidence in support of the application, their right to study will be rescinded. The BSAC program reserves the right not to refund the application fee and the admission confirmation fee to applicants.

7.2 Graduates from international or foreign schools not certified by the Ministry of Full ation must have their qualifications verified by the Council of University Presidents of Thailand as being equal to a qualification according to the Ministry of Education's Basic Education Core Curriculum.

7.3 Any applicant found to have provided false information or documents will have their admission revoked and may face legal action.

8. University Tuition Fees and Extra Surcharges

Tuition fees and other university surcharges are charged in accordance with official Chulalongkorn University announcements.
